Emerald City A Gem Of An Event

Imagine for a moment a diverse group of youth from different parts of Virginia. Some of them have had conflicts in the community, or even with each other where they now live. Some are impulsive and impatient, others demanding and self-centered.

Now picture them running around, cooperating, applauding each other's successes, trusting each other, collaborating to solve problems, overcoming challenges. Welcome to this year's Emerald City Field Day Challenge at Bon Air Juvenile Correctional Center!

Youth from a cluster calling itself The Emerald City recently joined together for their 4th Field Day Challenge. Planning for the 1½ hour event began two months earlier when the residents were asked which activities they would like to include, who should serve as their leader, and what leadership means. Before the event, the youth participated in a "circle-up" where all the activities were explained, behavioral expectations set, and the importance of teamwork stressed. The day of the event, they participated



in physically and intellectually challenging activities that included blindfold cotton ball pick, water balloon toss, water cup pass, three-legged obstacle course sack race; football toss, "moving on up" cup activity; human Hula Hoop pass, and the cereal box puzzle. Along with these challenges came life lessons in patience, sharing, the importance of planning, strategizing, compliance, and following directions.

The PAP: A Recipe For Success

You Can Help Your Child Make Best Plan For His Life



If you are excited about learning another way to support/assist your child, read on about the Personal Action Plan (PAP).

The PAP is a document developed by vour loved one to guide their personal choices while with DJJ and continues beyond release into the community. Youth assigned to Bon Air Juvenile Correctional Center (BAJCC) begin to develop a PAP during Phase I, while youth assigned to an alternative direct care placement, with assistance from a reentry advocate, begin to develop a PAP within the first 30 days of placement. The PAP is an ongoing living document which will likely be modified by youth over time. They write their own goals, with help from staff and peers who encourage them to think openly and freely about their personal goals and what they need to do to achieve them. The PAP helps youth identify the challenges they have faced, the reasons they committed their offense, and ways to prevent reoffending and how to achieve the goals they have set for themselves.

Parents and other supportive adults are critical to this process. Next time you attend Treatment Team or you



see or speak to your loved one, in addition to updating them on what is going on at home, consider talking to them about their PAP. Some questions to ask: Tell me about the goals you set in your PAP? How are they going? Is there anything I can do to help? Showing a genuine interest and a non-judgmental

approach coupled with openended questions can encourage them to think through the challenging journey of defining who they are and what they want out of life. To learn more about the PAP, please refer to the Parent Handbook, and/ or ask your child or anyone on your child's Treatment Team.

Katina Poole-Berry


Katina started her career as a teacher in her hometown immediately after completing her undergraduate degree in 1997, She joined Bon Air JCC in 1999 as an educator, and 23 years later, she is still here working with our youth!

In her classroom,

where she teaches economics and personal finance, they create their own "utopia." She encourages her students to investigate concepts and ideas, and urges them to use their imagination to dream, discuss and decide, and collaborate. "I teach my students about choices and the consequences of our choices," she says. "I get them to embrace the fact that their past does not define their present, and to change the narrative if they do not like their story.

"My hope is that all my students use what I teach them to make decisions that will improve their lives both financially and personally."

Success Story: What Advocacy Is All About

Northern Region Reentry Advocate **George Peoples** shared a recent success story of a resident who entered the system unmotivated and without job skills. With Mr. Peoples' help and encouragement, the resident began to understand the need for employable skills, completed the barber program, along with several other certifications, and graduated while with DJJ.

After the resident was released, George took him to an interview at a business where he had established contacts. He also helped the youth see his own potential, and all the areas he could spotlight that made him a desirable employee. George also obtained a bonding letter for the youth. The youth was hired, based on his skills and presentation. While working that job, the youth was connected with peer-to-peer mentoring and helped to secure a barber position. He chose to keep both jobs, and has proven himself to be a worthy and successful employee.

Reentry Advocates

The Reentry Advocates serve each region to help prepare committed youth for a seamless transition back into the community. Reentry Advocates help with the reentry process by connecting youth to employment services, providing support and assistance in post-secondary and vocational service, linking youth as well as their families to community agencies for services and ensuring youth have identification documents.
